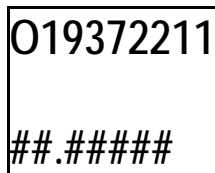

The recall of the product was initiated following the Information from federal regulators of a positive test for salmonella in a specific lot (**Production Block 937**) of green onions supplied by Circle Produce to several shippers, including Dynasty Farms. Our concern is that any of the above listed products containing the **Production Block 937**, already in distribution channels, may also be

contaminated with the same pathogenic organism. Consumption of this product by consumers represents a potential health hazard.

Pacific International Marketing and Dynasty Farms, requests consignees (wholesalers and retailers) to hold and discontinue selling their existing stock of this product, and destroy or return any remaining inventories of the recalled products to Cool Pacific Cooling, Attn: Mr. Hubbard, 1160 Terven Ave., Salinas, CA, (831)-757-9094 . If you have redistributed or sold this product to other retailers, please notify your clients as to the status of this product and whom they may contact for further information at Dynasty Farms.
